

## **American Diabetes Association Urges Federal Action to Lower Prescription Drug Prices**



The American Diabetes Association® (ADA) last week recommended urgent federal action to bring down skyrocketing drug prices before the Senate Health, Education, Labor and Pensions (HELP) Committee. In a statement for the congressional record submitted in conjunction with the HELP Committee's Primary Health and Retirement Security Subcommittee's recent hearing exploring reasons the U.S. pays the


highest prices in the world for prescription medications, ADA CEO Tracey D. Brown spoke to the unique financial challenges faced Americans with diabetes and stressed the need for immediate reliefespecially during the ongoing COVID-19 pandemic that has only compounded existing financial strain.

"The price of insulin alone has roughly tripled in the past decade, increasing from less than \$100 for an average vial in 2009 to nearly \$300 for the same vial today, even though today's insulin is nearly the exact same product as it was ten years ago. With these facts in mind, it should be little surprise that Americans spend more treating diabetes than any other chronic condition; that people with diabetes in the U.S. spend two and a half times more on health care than those who do not have diabetes; that they account for \$1 in every \$3 spent on prescription drugs, and 25 cents of every dollar spent on health care, in America today; and that one in four insulindependent Americans report rationing their insulin supply due to financial difficulty," wrote Brown.

"While Congress has for some time considered policy approaches to make drug costs Subcommittee and Congress more broadly to prioritize policy approaches that will serve the medical interests of patients and put money back in their pockets. Proposals that simply shift funds among players in the supply chain are not going to serve patients if patients themselves are not realizing savings-at the pharmacy counter, in their premiums, and in the cost of deductibles. Practical approaches that put patients first should be the first goal of any effort to make drugs more affordable."

The ADA implores leaders in government to take aggressive action to lower the cost of prescription drugs and looks forward to continuing to work with Congress to ensure that all Americans with diabetes can afford to stay safe and healthy.

## Munster High School Speech team captures 11th straight Class AA State Championship at the 2021 Indiana High School Forensics Association's Speech Finals on March 13

Wins prestigious Ralph Lawson Trophy for the ninth time

Munster, Indiana, March 16, 2021—Munster High School's Speech team won the 2021 Indiana High School Forensics Association's (IHSFA) Class AA State Tournament held virtually on Saturday, March 13. The victory is the school's 11th straight State Championship in the Class AA division.

The Mustangs entered the competition's elimination rounds, advancing 29 entries to the semi-finals and 19 entries to the final round. According to Jordan Mayer, who has directed Munster High School's Speech & Debate program since 2010, Munster's Speech team had the highest number of students advancing in the tournament and, with 206 points, was awarded the Ralph Lawson Trophy, which is bestowed on the overall State Championship team, regardless of Class size. This honor is Munster's ninth overall State Championship in the last 11 years. Fishers High

School in Fishers, IN placed second with 161 Points.

"Our students understood that this season would look different," Mayer said, "They stepped up by adapting to the virtual world. They partnered their talent and passion with deliberate practice and came prepared to compete." Team members included:

## COVID-19: What You Should, and Shouldn't, Do When Being Vaccinated

The number of new COVID-19 cases in the U.S. continues to decline, down 15 percent from two weeks ago, but experts caution everyone must continue taking steps to slow the spread of the virus.

As of March 17, some 537,000 people have died from COVID-19 in this country and more than 29 million people have been infected with the coronavirus.

#### **VACCINE UPDATE**

According to the Centers for Disease Control and Prevention (CDC), more than 73 million people have received at least one dose of a COVID-19 vaccine, including about 40 million people who have been fully vaccinated. Providers are administering about 2.47 million doses per day on average. State and local governments decide when each group gets access to vaccines. Visit your state or local health department for more information on eligibility and availability in your area.

## BEFORE AND AFTER VACCINE

- Don't take over-thecounter medicine, such as ibuprofen, aspirin, or acetaminophen, before vaccination to prevent vaccine-related side effects.
- After getting vaccinated you can take over-the-counter medicine, such as ibuprofen, acetaminophen, aspirin, or antihistamines, for any pain and discomfort you may experience.

- Don't take antihistamines before getting a COVID-19 vaccine to try to prevent allergic reactions.
- If you take these medications regularly for other reasons, you should keep taking them before you get vaccinated.
- You are considered fully vaccinated two weeks after your second shot of the Pfizer-BioNtech or Moderna COVID-19 vaccine, or two weeks after the single-dose J&J/Janssen COVID-19 vaccine.
- After you've been fully vaccinated against COVID-19, you should keep taking precautions in public places like wearing a mask, staying 6 feet apart from others, avoiding crowds and poorly ventilated spaces, and washing your hands often.
- After you are fully vaccinated for COVID-19, you may be able to start doing some things that you had stopped doing because of the pandemic. Learn more about what you can do when you have been fully vaccinated.
- The CDC recommends that people don't travel at this time. If you do travel, follow all CDC recommendations before, during and after travel.

Some people experience mild discomfort after they get a vaccine. This means the vaccine is working and creating an immune response in your body. These may include pain, redness, swelling, being tired, headache, muscle pain, chills, fever or nausea.

Side effects after your second shot may be more intense than the ones you experienced after your first shot. These side effects are normal signs that your body is building protection and should go away within a few days.

WHAT THE RED CROSS IS DOING As COVID-19 vaccination efforts continue, the Red Cross is supporting local communities across the country in their work when requested.

Depending circumstances, our support may include helping to set up vaccination sites, collecting information from people being vaccinated, and providing water and snacks for medical staff and people waiting to be vaccinated. As of March 15, the Red Cross has participated in 117 vaccine support missions across 29 states. Red Cross volunteers who are medical professionals may also be working with local authorities to help give vaccinations if their state licenses permit them to do so. The Red Cross

is also helping to vaccinate U.S. service members on bases around the globe and are active in U.S. veterans' hospitals.

If you have COVID-19 symptoms and want to get tested, call your health care provider first. Visit your state or local health department's website to look for the latest local information on testing.

# The Salvation Army of Lake County Continues To Do the Most Good One Year After the Start of the COVID-19 Pandemic



Organization remains committed to meeting urgent need while setting its eyes on addressing "pandemic poverty"

As the nation marks the anniversary of the COVID-19 pandemic, The Salvation Army of Lake County continues to address the longstanding issues of homelessness, poverty, and hunger, which have intensified and become more complex due to COVID-19. As a record number of families face the ongoing threats of "pandemic poverty," The Salvation Army remains committed to providing a hand up to our vulnerable neighbors most impacted.

People living in poverty felt the initial effects of COVID-

19 more quickly and acutely because they experienced a pandemic on top of alreadyexisting epidemics of need. COVID-19 forced a record number of Americans to seek assistance from The Salvation Army. That was certainly true in Lake County, which experienced a fivefold increase in need at the height of the pandemic. The most requested services were food and emergency financial assistance. Because The Salvation Army meets human need on the frontlines, local centers are often the first place that people turn to in a crisis. As such, the organization took intentional steps to meet the needs in Northwest Indiana.

- Served 23,538 meals; delivered 1,151 of those to homes
- Distributed 17,925 bags of groceries
- Provided 4,253 hygiene kits
- Supported 1,441 households with emergency financial assistance

"The Salvation Army was here before and during the pandemic, and we'll be here long after to continue supporting our neighbors in need," said Captain Brian Clark, Lake County Coordinator for The Salvation Army. "We are thankful for the generosity of our donors in Lake County, who made it possible to help a greater number of individuals than ever before with food and emergency financial assistance during this difficult time."

As needs evolved over the course of the year, The Salvation Army reimagined safe ways to meet them, such as expanding food pantry hours, distributing take-home meals from a mobile canteen, and offering hygiene kits.

To ensure service continues, The Salvation Army took the historic step of starting its 2020 holiday fundraising campaign early to ensure struggling Americans had a bright Christmas. Nearly \$500,000 was raised locally, which will help power 2021 services, but demand is expected to far outpace resources. As neighbors face threats of eviction and financial loss, the majority of clients are families who live paycheck to paycheck. In response, Salvation Army will remain focused on vulnerable families, and keeping people in their homes through rent and utility assistance.



Hammond Mayor Thomas M. McDermott, Jr. is pleased to announce that the City of Hammond is expanding

their BLUENET System. The expansion will allow businesses and citizens to voluntarily connect their camera systems with the Hammond Police giving the police the ability to access their camera system when a crime has been committed or when an investigation is underway, to aide in solving crimes.

"This expansion to the BLUENET System will enhance the crime fighting cameras, License Plate Readers, and the body cams already in use," stated Mayor McDermott. "It's important to keep up with

the new technology to assist in fighting crime and keeping Hammond safe. It also provides our citizens an opportunity to assist in keeping their community safe".

Several years ago, the Hammond Police implemented a contact protocol system increasing the number of contacts officers had with observed infraction violators. HPD then added LPRs which were installed in new patrol vehicles. The LPRs assist the police in detecting persons wanted for a crime already committed. Within the first

hour of the LPRs being in use, it notified officers of a stolen vehicle, and has helped solve many other crimes since.

"I wish they had this technology when I started my career with the Hammond Police", stated Police Chief William Short. "With this knowledge, we have become more proactive instead of reactive. Partnering with our businesses and citizens will only have a positive effect on the tools we have to fight crime."
