A \$10,000.00 Reward is being offered for information

Hammond Mayor Thomas M. McDermott, Jr. announced that protective measures are being taken in the south Robertsdale area waterways to protect our natural resources and quality of life in our community.

Wolf Lake

Residents using the recreation facilities at Wolf Lake Memorial Park may have noticed that a protective water boom has been placed near the stormwater outfall at the Hammond Sanitary District Stormwater Pump Station located near the 2400 Block of Calumet Avenue. An oily substance was observed at that pump station that appears to have come from an illicit discharge into a storm sewer. The pump station was cleaned out using vacuum trucks and oil absorbent booms were placed in the lake as a protective measure. The source of the oily substance is being investigated by the Hammond Sanitary District personnel. The Hammond Sanitary District is seeking the public's help on locating the source of this illegal dumping. A \$10,000.00 Reward is being offered for information leading to arrest and conviction of the person or persons responsible for the illicit discharge. George Lake North Basin Discharge Discovered

The city of Hammond and the Hammond Port Authority were notified on Monday April 5, 2021 that a resident of Hammond had observed a greyish milky discharge in the North Basin of George Lake on Saturday April 3, 2021. The Hammond Port Authority and the Hammond Sanitary District responded to

the discharge location which was in the far southeast corner of the North Basin of George Lake. The discharge appeared to be associated with a buried metal pipe. The origin of the pipe is being investigated. Upon investigation it was determined the greyish material, and other similar materials had impacted a significant area on the East shore of the North basin of George Lake. The North basin of George Lake is part of the development of the Lost Marsh Environmental and Recreation Area and is protected by a Conservation Easement that is governed by the city of Hammond, the Indiana Department of Natural Resources (IDNR) and the Indiana Department of Environmental Management (IDEM). Hammond Port Authority is responsible for overseeing the Lost Marsh Environmental and Recreation Area and has placed collection booms at the discharge pipes in order to collect and prevent any additional grey materials from entering the waters, wetlands, and uplands of the North Basin.

The city of Hammond and Hammond Port Authority have reached out to both the IDNR and IDEM to request: their investigative support in identifying the source responsible for the discharge, their assistance in determining the extent of the greyish material(s) impact on the North Basin's waters, wetlands and uplands, and assistance in crafting a Remedial Plan to correct the adverse environmental impacts created by the discharge.

The efforts listed above are designed to protect Hammond's natural resources and see that the quality of life in our community is not only protected but enhanced.



Purdue Northwest offers summer engineering camps

HAMMOND and WESTVILLE, Ind. — Purdue University Northwest's (PNW) Department of Mechanical and Civil Engineering will offer summer enrichment camps for middle and high school students

interested in learning more about mechanical and civil engineering disciplines.

The Purdue Northwest Summer Engineering Camps will take place in June and July. Camp attendees can choose to attend virtually (via Zoom), or in-person at PNW's Hammond Campus, where university social distancing guidelines will be followed. Students will be introduced to fundamental concepts of civil and mechanical engineering through interactive, laboratory and classroom experiences, including the opportunity to visit the new PNW Design Studio.

Participants will engage in hands-on activities to explore various areas of engineering, and learn skills in team building, computer-aided engineering, laboratory experimentation and decision-making. All materials will be provided and participants will interact with current PNW students and faculty. Certificates will be presented at the end of each camp during a closing ceremony Friday afternoon.

Camp dates and details

The camp for middle school students is from 9 a.m. to 3 p.m. June 21 through June 25. The camp for high school students is from 9 a.m. to 4 p.m. June 28 through July 2. Sessions will be held in the Edward D. Anderson building, 6901 Woodmar Ave., Hammond.

Students must be entering sixth grade or higher in fall 2021 to be eligible to attend. The application deadline is May 25 and the cost per student is \$300.

What you need to know about COVID-19 vaccines and blood donation eligibility



Good news – In most cases, there's no blood donation deferral time if you receive a COVID-19 vaccine. However, knowing the name of the manufacturer is important in determining your eligibility to donate blood.

Individuals who have received a COVID-19 vaccine will need to provide the manufacturer name when they donate. Upon vaccination, individuals will receive a card or printout indicating what COVID-19 vaccine was received, and we encourage vaccinated people to bring that card with them to their next donation. In most cases, there is no deferral time for individuals who received a COVID-19 vaccine as long as they are symptom free and feeling well at the time of donation.

The following eligibility guidelines apply to each COVID-19 vaccine received, including second doses:

• There is no deferral time for eligible blood donors who have received a COVID-19 vaccine currently authorized in the U.S. including J&J, Moderna and Pfizer.

- Eligible blood donors who do not know what type of COVID-19 vaccine they received must wait two weeks before giving blood.
- If you have further eligibility questions, please call 1-800-RED CROSS (1-800-733-2767).

The American Red Cross follows FDA blood donation eligibility guidance for those who receive a COVID-19 vaccination, and deferral times may vary depending on the type of vaccine an individual receives.

ONGOING NEED FOR DONORS DURING THE PANDEMIC

The Red Cross has a constant and ongoing need for blood and platelet donations. With the ongoing pandemic, the Red Cross needs the help of blood and platelet donors and blood drive hosts to meet the needs of patient care.

The Red Cross is testing all blood, platelet and plasma donations for COVID-19 antibodies. As part of that effort, plasma from whole blood donations that test positive for COVID-19 antibodies may now help current coronavirus patients in need of convalescent plasma transfusions. We are committed to helping others in meaningful ways during this pandemic.

Donating blood products is essential to community health and the need for blood products is constant. As part of our nation's critical infrastructure, healthy individuals can still donate in areas that have issued shelter in place declarations or are operating under a phased reopening plan. The Red Cross follows the highest standards of safety and infection control, and volunteer donors are the only source of blood for those in need. As hospitals resume surgical procedures and patient treatments that were temporarily paused due to the COVID-19 pandemic, donors are urged to give now to ensure blood products are readily available for patients.

Gary Boys & Girls Club's Marcus Steele, Jr. Named Indiana Youth of the Year

Boys & Girls Clubs of Greater Northwest Indiana's Marcus Steele, Jr. was named Indiana's State Youth of the Year on Tuesday during a virtual ceremony with participants from Clubs across the state. Surrounded by his father and Boys & Girls Club staff, Steele sat centered in the organization's Administration and Resource Center conference room as he waited for the announcement.

When it came, staff erupted into applause and cheered as Steele stood and began clapping. He then spoke to the camera and addressed virtual participants, thanking Boys & Girls Clubs for "everything you've done for me and the other contestants around the state." Minutes later, with the ceremony over and the camera off, Steele hugged his dad.

"His mother and I are so excited and proud of him," Marcus Steele, Sr. said later.

Steele, a senior at Calumet New Tech High School, was selected from fifteen candidates from Indiana as part of Boys & Girls Clubs of America's Youth of the Year program. To get to State, Steele first had to be chosen as Boys & Girls Clubs of Greater Northwest Indiana's organizational Youth of the Year, a feat he accomplished in February.

Steele is Boys & Girls Clubs of Greater Northwest Indiana's third straight State Youth of the Year winner, following Merrillville's Azariah Avery last year and Portage's Sanja Kirova in 2019. This was also Steele's third year as the Gary Club's Youth of the Year candidate.

"This has been a long journey for Marcus," Steele, Sr. said. "But he's very calm, and he takes everything in stride. It's very rewarding right now."

As staff congratulated Steele after the ceremony, Boys & Girls Clubs president and CEO Ryan Smiley applauded him for his hard work and

for serving as a role model to younger Club members.

"We're so proud of watching you grow up into the outstanding young man you've become," Smiley said. "We know your future is very bright, and we're excited for what's coming next."

Steele's journey continues to the regional contest, which will take place in early summer and consist of Club members from around the Midwest. For being named the State Youth of the Year, Steele, who has been accepted to Ball State and plans to study construction management, will receive a \$2,500 scholarship from Boys & Girls Clubs of America and \$1,000 from the Indiana Area Council. Steele also received a \$5,000 scholarship for being named Boys & Girls Clubs of Greater Northwest Indiana's Youth of the Year. For Steele, the accomplishment isn't really about him. "It feels great, but I'm just another kid from Gary," he said. "Hopefully kids in Gary

will see this as something to be proud of and proof that they can do something great."

The Tree Campus Higher Education program honors colleges and universities for effective campus forest management and engaging staff and students in conservation goals. Purdue University Northwest students benefiting from \$3.8 million in new COVID-19 relief funds

Purdue University Northwest (PNW) is moving quickly to disburse \$3.8 million in newly released federal funds related to pandemic relief directly to its students with financial need.

PNW will have distributed nearly \$8.9 million in emergency funding directly to students over the past year. Although federal guidelines require universities to provide 50 percent of the emergency funding to students, Purdue Northwest decided to award 87 percent of all funds available to the university directly to students with financial need.

The current funds are available through the Higher Education Emergency Relief Fund II (HEERF II), authorized by the Coronavirus Response and Relief Supplemental Appropriations Act, 2021 (CRRSAA). PNW domestic students enrolled for the spring 2021 semester who are eligible for the federal Pell Grant, and those who have a Free Application for Federal Student Aid (FAFSA) on file, will receive awards. Furthermore, all PNW domestic students enrolled for the spring semester may apply for emergency funding of up to \$3,000 through a form on the PNW website, www. pnw.edu/heerf.

"PNW is continually focused on helping our students earn their degrees, and we are driving these newly available resources directly to students who need it most," said Purdue Northwest Chancellor Thomas L. Keon. "This extraordinary past year has brought out the greatest strengths of PNW's students – determination, grit and innovation to face any challenge. We will do all we can to support them."

In addition, PNW last year funded and distributed more than \$50,000 in scholarships for tuition relief. The university also raised more than \$42,000 through its We Care campaigns to assist students through the unique circumstances of the pandemic, designating those gifts to the PNW Dean of Students Emergency Fund. PNW anticipates additional funds authorized by the federal stimulus bill may be released soon, and will work to promptly disburse its share to students with financial need. "The reality is that most of our students attending PNW require some form of financial assistance. Beyond tuition, students have costs for books, technology and their day-to-day expenses like housing, groceries and health care," stated Yohlunda Mosley, vice chancellor of Enrollment Management and Student Affairs. "We know that the pandemic has challenged students financially over the last year and while the federal programs will not address all of their needs, they will provide some much appreciated relief."
