## NIRPC to hold public comment period on amendments of 2020-2024 and the 2022-2026 Transportation Improvement Programs

Northwestern Indiana Regional Planning Commission (NIRPC) will hold a 21-day public comment period on an amendment to the 2020-2024 2022-2026 Transportation Improvement **Programs** (TIP). The comment period begins today and will end on April 1, 2022. Amendment #22-22.45 contains railroad crossings project for INDOT in several municipalities in Northwestern Indiana.

NIRPC's TIP is a shortrange financial and spending plan for the utilization of federal transportation funding and for regionally significant projects. These federal funds can be used for highway, transit, and non-motorized

transportation projects. NIRPC's TIP includes projects undertaken by municipalities, counties, transit operators, and the State of Indiana. Federal planning regulations guide the preparation and development of the TIP documents.

2022 meeting of the Technical Planning Committee, followed by the April 21st, 2022 meeting of the NIRPC Commission.

#### THIS DAY IN HISTORY April 1, 1972

### First MLB players' strike begins

At 12:01 a.m. on April 1, 1972, the first collective players' strike in Major League Baseball history begins. The strike lasts 12 days, ending on April 13, and 86 games are cancelled, throwing the season into flux from the start.

The cause of baseball's first strike was the expiration of the league's three-year pension agreement. The Major League Baseball Players Association, led by seasoned union negotiator Marvin Miller, had made modest requests to increase benefits. However, the owners balked at the proposals, and never took the players' threat to strike seriously.

In his book, A Whole Different Ballgame, Miller wrote: "The last thing I expected in 1972 was a strike. The owners had decided to bring the Players Association's progress to a halt either by provoking a strike, which they felt confident of winning, or by forcing the players to back down and accept their unreasonable position in the negotiations."

As it turned out, the players were prepared to take control

of their own destiny. In fact, the players voted 663-10 in favor of authorizing their executive committee to call a strike. MLBPA general counsel Dick Moss advised the players that it was not the right time to strike because they had yet to be paid that season and didn't have a strike fund. But the players stood their ground.

Oakland A's star Reggie Jackson yelled at a meeting with Miller and Moss: "Goddammit, there are just times when you've got to stand up for your rights!" Although the players were not paid for the 12 days of the strike, their effort ultimately was a success. Owners agreed to a \$500,000 increase in the pension fund and to allow salary arbitration.

The 1972 MLB season yielded some bizarre results from the strike—some teams only played 153 games instead of the customary 162. The Detroit Tigers won the AL East by a half-game over the Boston Red Sox, who played one fewer game than the Tigers.

## City of Hammond (1847-1984) Chronology (part 4)

A little Hammond's history, for the young to learn and the old to remember

1896 1896 John Schmueser and Sons, painters and glaziers, opens for business on Sibley Avenue. The city purchases the site of Douglas Park. Home mail delivery begins with three carriers. Twenty year old James Bereolos founds the city's Greek community. Mrs. Trilla Bell Young and Mrs. Martha Wilson Ibach found the Hammond Woman's Club. Bieker Brothers open a grain and fuel dealership. All Saints Roman Catholic Church is dedicated.

**1897** The Roby Robertsdale Lakefront area is annexed after a lengthy court fight. Saint John's Roman Catholic Church is built.

1898 W. B. Conkey Printing and Book binding Company, one of the world's largest book producers, is induced to locate in Hammond by Thomas Hammond's salesmanship, eighty acres of land, and a rumored gift of \$75,000. The plant immediately employs a thousand workers. Simplex Railway Appliance Company

builds a plant on the site of the Hohman Inn. Saint Margaret Hospital opens in the Lautman home on Clinton Street, and will move to a permanent hospital building two years later. The Huehn Opera House opens. The Hammond Chapter of the Loyal Order of the Moose opens. A new brick and stone Lafayette School building is erected at Sibley and Calumet. The city purchases a twenty five acre site for Harrison Park. Company "A" of the 161st Indiana Volunteers is formed for duty in Cuba.

**1899** The Hammond Elks Club is formed. Three year old Kneseth Israel (now part of Congregation Beth Israel) erects a synagogue.

1900 The census reports a population of 12,376 in Hammond, a 128 percent increase in ten years. Fifty-eight percent of the residents of Lake County now live in North Township. The three-story Washington School opens on Williams Street. The Hammond Gas and Electric Building opens on Hohman Avenue. Dr. Lena B. Watson becomes Hammond's first woman dentist.

House burns, bringing sudden unemployment to eighteen hundred workers and hard times to the young city. The Indiana Harbor Belt Railway begins service. The Hammond Commercial Club is organized to promote business in the city. The Chicago and Indiana Air Line Railway, the ancestor of the South Shore Line, is organized, but construction delays will prevent it from serving the city until 1908.

1902 Hammond Board of Trade is established Hammond Businessman's Association formed. Hammond Labor Temple opens. First Trust and Lake County Trust and Savings Bank are organized. The Chesapeake and Ohio Railroad tracks cross the city. Franklin School Opens. John Fitzgerald opens the Hammond Distilling Company, soon to become one of the nation's largest whiskey producers. Hammond's school population reaches fifteen hundred.

1903 G. H. Hammond Company is absorbed by the Armour interests, and plans to rebuild the local packinghouse are dropped.


Mayor Armanis Knotts organizes an **Industrial Committee** that attracts eleven substantial businesses to the city during his term of office. William H. Gostlin, A. Murray Turner, and Peter W. Meyn merge their real estate interests into the new firm of Gostlin, Meyn Realty Company which attracts dozens of concerns

to the city over the next quarter century. All four of the city's fire stations are equipped with horse-drawn steam pumpers. Water from Lake Michigan is pumped to homes in the city. First Evangelical Church is organized in Robertsdale. Hammond Knights of Columbus is founded. Superior Court House is built on Hohman Avenue at Rimbach, bringing improved county services to the industrial cities of North Township. Lake Front Park opens on four acres. Towle Opera House opens on Hohman at Sibley, and immediately becomes the city's entertainment center. Blacksmith and wagon maker Otto Knoerzer invents a potato digging machine and opens the Champion Potato Machine Company to market it and other agricultural equipment.

are in service in the city. Reid-Murdoch Company, wholesale canners and packers, opens for business. The Federal Building opens at the comer of State and Oakley Streets. Max Nowak opens the Nowak Milling Company, which operates until 1938. Fitzhugh Luther Locomotive Company succeeds Torbert & Peckham. The firm will become U.S. Locomotive, and will close in the mid-twenties. Enterprise Bed Company begins to manufacture the Hygeia bed spring and mattress. Henry Schmueser's Western Grain and Products Company begins producing Straube Piano cattle feed. Company moves to Hammond from Downer's Grove, Illinois. Frank S. Betz opens a successful medical equipment manufacturing company, which closed in 1924.





#### **DETAILS**

The Federal Bureau of Investigation's (FBI) Washington Field Office is seeking the public's assistance in identifying individuals who made unlawful entry into the United States Capitol Building and assaulted federal law enforcement personnel on January 6, 2021, in Washington, D.C.
