

NEW \$25M RESIDENTIAL DEVELOPMENT IN DOWNTOWN HAMMOND



Hammond Redevelopment Commission and ATG Real Estate Celebrate new residential development Mayor Thomas M. McDermott, Jr. and the Hammond Redevelopment Commission are pleased to announce the approval of a development agreement with ATG Real Estate to build 208 market rate apartments in downtown Hammond. Along with this development, there will be new commercial and retail space and a brand-new plaza at the corner of a newly designed Rimbach Street and Hohman Avenue. "Our planning team worked closely with ATG to get this exciting development in our downtown," said Mayor McDermott. "This \$25M investment into our downtown is aligned with the City's Downtown Master Plan from Jeff Speck and will bring hundreds of people into downtown and add to the thriving core we are developing."

ATG Real Estate Development LLC's Founding Director, Eric T. Gastevich, says Hammond is "a wonderful City in which to work. Mayor McDermott has put together a Redevelopment Commission that is a first-rate, reliable team of people and we're delighted to begin work with this team on the first new multi-use project in downtown Hammond in many decades." ATG expects to break ground this fall and will have the first apartments available for occupancy by the summer of 2023. The City will provide a 10-year tax abatement, as well as a land acquisition loan for the project

Devastation in Ukraine: How the Red Cross is Helping

As conflict continues to roil Ukraine, the Red Cross is vowing support for the most vulnerable. More than two million people have fled Ukraine to neighboring countries and even more are displaced within the country itself. As the fighting intensifies, so does the dire humanitarian situation and needs on the ground.

"The escalating conflict in Ukraine is taking a devastating toll. Casualty figures keep rising while health facilities struggle to cope. We already see longterm disruptions in regular water and electricity supplies. People calling our hotline in Ukraine are desperately in need of food and shelter," International Committee of the Red Cross (ICRC) Director General Robert Mardini said.

In Neighboring Countries: Help to Those Fleeing their Homes

People impacted by the conflict are heartbroken, as they are forced to flee from their homes. Red Cross and Red Crescent teams in the region are rolling up their sleeves to assist with the dire humanitarian crisis as it unfolds. In Poland, Hungary, Slovakia, Romania, Moldova, Croatia, Lithuania and Russia, Red Cross volunteers are supporting displaced people. **Teams are:** Distributing food, water, clothing, bedding, hygiene
sets, blankets and even handing
out SIM cards so that families can
stay connected amid the turmoil.
Supplying baby products and
services for children. • Pitching
tents and preparing shelters for
refugees who need a comforting
place to sleep and feel safe. •
Providing much-needed mental
health and emotional support.

Role of the American Red Cross

The American Red Cross has deployed international crisis responders to Poland, Moldova, Hungary and Romania to provide humanitarian relief in support of the international Red Cross operation helping families who fled their homes. These highly trained crisis responders-who are lending skills such as information management, GIS systems, and leadership-are supporting onthe-ground relief efforts alongside local teams, including the Polish Red Cross and Moldovan Red Cross. Additionally, in line with its work supporting military families, the American Red Cross has sent trained staff to Europe to support emergency communication needs of U.S. military members, so they can stay in touch with family members back home. The Red Cross Hero Care Network is a Congressionally-chartered

program that connects service members and their families in times of need. Red Crossers are also distributing comfort kits, containing hygiene items and other necessities to service members and U.S. State Department staff.

Blood Services

At this time, the American Red Cross is not shipping blood products to Ukraine. The American Red Cross does not ship blood products outside the U.S. without a specific request from the U.S. Department of State, from the United Nations, or unless we have a request from affected Red Cross or Red Crescent societies abroad.

International Humanitarian Law

ICRC called on authorities to adhere to international humanitarian law and to protect civilians and infrastructure delivering essential services, including power and water facilities, schools and hospitals. Peter Maurer, president of the ICRC, requested protection for humanitarian action so that aid agencies can maintain access to civilians. ICRC has also called for parties to agree to terms so safe passage of civilians is possible.

Protecting Red Cross Workers

The Red Cross emblem is strictly regulated under

humanitarian law. In armed conflict, it may be used by medical staff and facilities, including army medics and vehicles. It may also be used by Red Cross and Red Crescent workers, vehicles, facilities and the humanitarian relief they bring.

Resources for People Affected in Ukraine

The ICRC has published a list of resources for people needing urgent help in Ukraine, including medical care, evacuation support, mental health support, shelter and safety tips. **How to Find a Missing Loved One**

Those unable to get in touch with US citizens missing in Ukraine or Russia should contact the US Department of State Overseas Citizens Services Office online or at 1-888-407-4747.

Telecommunication systems in the region have been affected. Some family members are still able to keep in contact with each other, but the situation is rapidly changing as fighting continues. As of now, the majority of affected civilians have been maintaining their own family links via cell phones. Lyndon B. Johnson calls for equal voting rights

On March 15, 1965, President Lyndon B. Johnson addresses a joint session of Congress to urge the passage of legislation guaranteeing voting rights for all.

Using the phrase "we shall overcome," borrowed from African American leaders struggling for equal rights, Johnson declares that "every American citizen must have an equal right to vote." Johnson reminds the nation that the Fifteenth Amendment, which was passed after the Civil War, gave all citizens the right to vote regardless of race or color. But states had defied the Constitution and erected barriers. Discrimination had taken the form of literacy, knowledge or character tests administered solely to African Americans to keep them from registering to vote.

"Their cause must be our cause too,"Johnson said. "Because it is not just Negroes, but really it is all of us, who must overcome the crippling legacy of bigotry and injustice. And we shall overcome."

The speech was delivered eight days after racial violence erupted in Selma, Alabama. Civil rights leader John Lewis and over 500 marchers were attacked while planning a march from Selma to Montgomery to register African Americans to vote. The police violence that erupted resulted in the death of a King supporter, a white Unitarian Minister from Boston named James J. Reeb. Television news coverage of the event galvanized voting rights supporters in Congress.

A second attempt to march to Montgomery was also blocked by police. It took Federal intervention with the "federalizing" of the Alabama national guard and the addition of over 2,000 other guards to allow the march to begin. The march to Montgomery finally began March 21 with over 3,000 participants under the glare of worldwide news publicity.

The violence, however, continued. Just after the march was successfully completed on March 25, four Klansman shot and killed Detroit homemaker Viola Liuzzo as she drove marchers back to Selma.

On August 6, 1965, Johnson signed the Voting Rights Act, which made it illegal to impose restrictions on federal, state and local elections that were designed to deny the vote to Black Americans.

While state and local enforcement of the act was initially weak, mainly in the South, the Voting Rights Act gave African American voters the legal means to challenge voting restrictions and vastly improved voter turnout. In Mississippi alone, voter turnout among Black voters increased from 6 percent in 1964 to 59 percent in 1969.

In 1970, President Richard Nixon extended the provisions of the Voting Rights Act and lowered the eligible voting age for all voters to 18.

City of Hammond (1847-1984) Chronology (part 3)

A little Hammond's history, for the young to learn and the old to remember

1888 Democrat Thomas Hammond becomes the city's second mayor and will be reelected in 1890 and 1892. He will resign in 1893 to serve in Congress. Ernst Aimet's Deutsche Volks-Zeitung begins weekly publication to serve Hammond's growing German-American population. First Christian Church is constructed on Indiana Avenue. First Congregational Church on Hohman Avenue is dedicated. Marcus Towle and James Young finance the construction of the Chicago & Calumet Terminal Railroad, which connects Hammond's growing industries with Chicago trunk lines. A shipping channel is dredged in the Hammond portion of the Grand Calumet River, but packinghouse wastes and silt close it almost immediately, and the project is abandoned in

1895. Saint Paul's Episcopal Church is founded.


1889 A division in the congregation of Saint Paul's Lutheran Church results in the formation of Saint Johannes Evangelical Lutheran Church on Gostlin Street. Zion Methodist Church is organized. Knights of Pythias founded.

1890 The federal census reports 5,248 citizens of Hammond. Lakeside Nail is organized by Ohio interests to manufacture nails from old steel rails, and hires 250 men. The company becomes Chicago Steel in 1904. Lafayette School, then called East Side School, opens at Sibley and Calumet with two teachers and seventy-five students. Edward C. Minas, a clerk in Towle's general store, opens his own hard- ware store. The city's attempts over the winter of 1890-91 to become the county seat are defeated by a coalition of south Lake County and LaPorte County legislators in the General Assembly. Saint

Casimir's Catholic Church is dedicated. Riverside School opens in a building at Truman and Calumet.

1892 Marcus Towle organizes the Kingsley Foundry, which was later sold to Mackie Steel Tube. The Hammond Electric Railway Company receives a city franchise. Thomas Hammond's Commercial Bank of Hammond is granted a charter. Leo Wolf and Carl Kaufman open the Lion Shoe Store. Moses Rothschild opens "The Model," a men's clothing store. Samuel G. Carley opens Carley's Best Movers. A syndicate of Chicago" sportsmen " opens a casino, hotel, racetracks, and boxing arena in Roby. Local officials welcome them, but state officials declare war. Years of harrassment and militia raids and the legalization of racing in Illinois curtail Roby. The last track closed in 1905, after the Assembly forbade all betting on horse races.

water supply, Hammond seeks access to Lake Michigan by annexing а strip of land between Whiting's Crossing and the state line. The move was temporarily blocked by legal resistance from property owners in the area. The twoyear-old First Presbyterian congregation builds a church

on Hohman near Ogden. The congregation will build new churches in 1918 and 1976. The Hammond Electric Railway becomes part of the Hammond, Whiting, & East Chicago Railway. That company's tracks will make downtown Hammond the shopping center of Lake County.

1894 Hammond City Council votes to annex the unincorporated area of Whiting's Crossing, which includes the Standard Oil refinery. Strenuous legal opposition from the oil company and the incorporation of the Town of Whiting blocks the move. Hammond finally assumes responsibility for public education within its boundaries, and replaces North Township direction with a City School Board. W. C. Belman becomes the first superintendent, and oversees much of the system's development. A second Central High School is built on the site of the first. Hammond Schools enrolls 1.377 students. Hammond's City Marshal and his deputies are replaced by a city police force under Chief A. F. Malo. Violence spills over the state line during the bloody Pullman Strike. On July 8 Hammond carpenter Charles Fleischer, an innocent bystander, is killed by federal troops fighting a mob bent on destroying railroad property. W. F. Paxton founds the Paxton Lumber Company.

1895 A new Superior Court District, consisting of Lake, Porter, and LaPorte counties, is formed. John Millikan opens a sporting goods store.
