Overdose Death Leads to Discovery of Overcrowded Illegal Basement Apartment

Hammond Indiana Police Department responded to a distress call reporting an overdose death at a multi-unit building in the 1100 block of Indiana Street. While investigating the apparent overdose death of a resident, officers were informed by an upstairs resident that there were 13 individuals residing in the basement of the premises.

Upon further investigation, officers discovered a total of 13 occupants, including nine children ranging from 2 months to 14 years old, two adult women, and two adult men, all from Venezuela. The basement apartment was found to be in violation of several city ordinances and inadequate for housing. “Over the last 20 years as mayor, I’ve had to visit horrific scenes of tragic fires where people have died, trapped in illegal basement apartments. We have worked very hard to eliminate these illegal apartments and hold the owners responsible and will do the same here,” said Mayor Thomas M. McDermott, Jr.

Due to the severity of the overcrowded and substandard living conditions, the Hammond Police Department’s Code Enforcement Division was notified and promptly dispatched to the scene. Upon evaluation, the city’s code enforcement team identified numerous violations, rendering the home a hazard to the residents and the surrounding community. Overloaded extension cords, inadequate exits, windows, and walls were found in the initial inspection. “This type of illegal basement apartment

places people at extreme risk and danger, with owners often preying on marginalized people and those without means to find other adequate housing,” said Kelly Kearney, head of the city’s Department of Inspections.

Further inquiries revealed that the living arrangements for the individuals from Venezuela were made by Pastor Manuel Corazzri of an East Chicago, Indiana church. As a result of the inspection, the residence was deemed uninhabitable, and the occupants were issued a notice to vacate the premises within 10 days. “If the investigation determines that the Pastor believed he could send 13 undocumented people to live in an illegal basement apartment in our city, I will ensure that he be held responsible for these actions. The City of Hammond is not open to this type of illegal criminal activity and he has placed people in significant harm, including children.”

The Hammond Police Department is actively conducting an ongoing investigation into this matter and will collaborate with relevant federal authorities to address any potential violations of immigration or other pertinent laws.

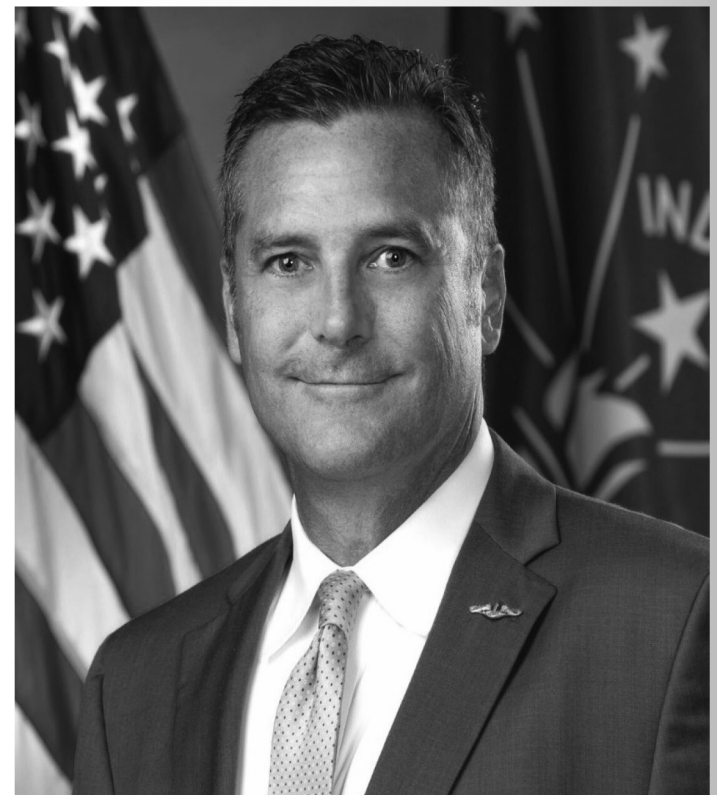

“Rudy”: Filmed in Whiting 30 Years Ago

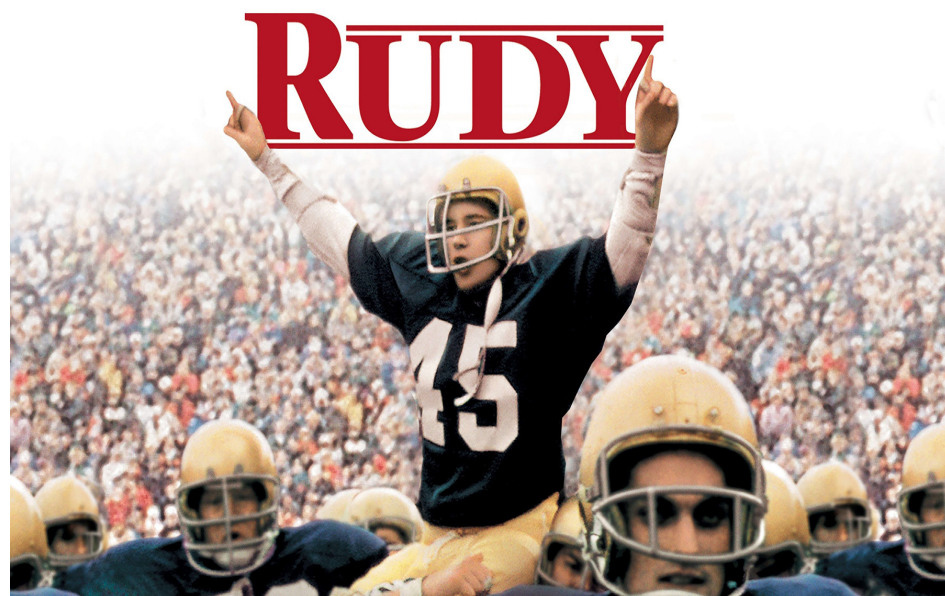
Whiting can't quite claim it's the "Hollywood of the Calumet Region," but in the 1980s there were two motion pictures partially filmed in Whiting. And in 1993, Whiting was one of the locations where they filmed "Rudy," considered by many to be among the top sports movies of all time. October was the 30th anniversary of the film's release. In honor of that anniversary, there are special showings of "Rudy" at theaters across the country. If you go, here's what to look for if you want to spot Whiting's appearance in the film.

This area of Whiting was just south of the houses on Standard Avenue. It was used in the film "Rudy" in a scene where Rudy and friends are playing football. Both the tracks and many of the houses on Standard Avenue

are gone. Today the area of the tracks is a parking lot just to the east of Oil City Stadium.

"Rudy" is based on the life of Rudy Ruettiger, a young man who was told he was too small to play college football. But he overcame the odds and obstacles and fulfilled a dream of playing for Notre Dame. The real-life Rudy was born and raised in Joliet. Whiting was used as a film location because it had "the look and feel" of Joliet in the 1950s, the years when Ruettiger grew up there. Don't watch the movie thinking you'll hear Whiting mentioned. Whiting was just a stand-in for Joliet.

Filming in Whiting took place in December of 1992. Sunbeam Productions, which handled the logistics of the production, planned to bring in snow making machines because



the scenes here needed to look like Christmas time. Nature, however, provided its own snow and gave the production team what it needed.

The filming was done at the eastern end of 119th Street, between Front Street and Schrage Avenue, as well as in the area of Standard Avenue. Many of the Whiting landmarks which appeared in the film are now gone, including the railroad tracks that ran to the south of Standard Avenue. It is now a parking area just to the east of Oil City Stadium. In the film, that's the area where the boys are playing football during Rudy's life in Joliet.

Two other Whiting locations in the film are also gone. Game Time bar, which was located on 119th Street at Standard Avenue in 1992, was used as a bar which was frequented by Rudy's family and coworkers. A house at 1718 119th Street was used as the Ruettiger family home.

"Rudy" was written by Angelo Pizzo, who wrote "Hoosiers," the classic Indiana basketball movie. Whiting had a bigger

role in the film "Four Friends," which was written by Steve Tesich. Tesich, who grew up in East Chicago, also wrote "Breaking Away," the classic Indiana-based bike racing movie. "Four Friends" was released in 1981. Six years later, in 1987, "Light of Day" was partially shot in Whiting, bringing star Michael J. Fox to the city. But "Rudy" was easily the biggest box office hit of all the movies filmed in Whiting, .

Babe Didrikson Zaharias wins final LPGA tournament of her career



On May 1, 1955, Babe Didrikson Zaharias, one of the greatest athletes in sports history, wins the Peach Blossom LPGA Tournament in Spartanburg, S.C. The victory, the 41st LPGA title of her career, comes as a Didrikson Zaharias continues her battle with colon cancer. After a strong start to the tournament, Didrikson falters in the final two rounds, but she holds off runner-up Marilynn Smith and wins by two strokes.

The Babe's victory in South Carolina was the final time she set foot on a golf course for an LPGA event. Despite her worsening sickness, she summoned a legendary effort that weekend and would later write in her biography, "I still wasn't ready to admit that I wasn't in the condition to play. I was more determined than ever to win one."

Over the course of her amateur and professional golf career, Didrikson Zaharias won 82 tournaments, including 10 majors. Her final major win, at the U.S. Women's Open, came after her cancer diagnosis. She won that tournament by 12 strokes while wearing a colostomy bag.

Golf probably wasn't even Didrikson's best sport. She dominated track and field at the 1932 Olympics Games, finishing with gold medal in the 80-meter hurdles, she equaled the world record of 11.8 seconds in her opening heat. In the final, she broke her record with an 11.7 clocking. In the javelin, she also won gold with an Olympic record throw of 43.69 meters. She earned a silver in the high jump.

Didrikson is the only track and field athlete, male or female, to win individual Olympic medals in separate running, throwing, and jumping events

In March 1934, Didrikson pitched a total of four innings in three Major League spring training exhibition games

She was named the 10th Greatest North American Athlete of the 20th Century by ESPN, being the highest-ranked woman on their list.

On September 27, 1956, less than two years after her final golf tournament victory, Didrikson Zaharias died. She was 45.

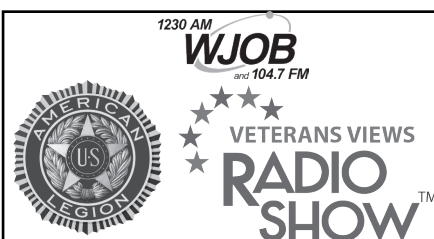

What is Venous Thromboembolism

Venous thromboembolism (VTE) is a blood clot that starts in a vein. VTE encompasses two interrelated conditions: deep vein thrombosis (DVT), which is the development of a clot in the deep veins of the extremities or pelvis, and pulmonary embolism (PE), which occurs when a clot breaks free, usually from a deep vein in the legs, and becomes lodged in the lungs. Serious complications may result from VTEs so it is important to learn about the warning signs, symptoms and prevention.

Venous thromboembolism (VTE) refers to a blood clot that starts in a vein. As many as 600,000 VTE events occur each year in the United States. There are two types:

- **Deep vein thrombosis (DVT)**
Deep vein thrombosis is a clot in a deep vein, usually in the leg or pelvis. DVT sometimes affects the arm or other veins.
- **Pulmonary embolism (PE)**
A pulmonary embolism occurs when a clot breaks free from a vein wall, travels to the lungs and then blocks some or all of the blood supply. Blood clots originating in the thigh are more likely to break off and travel to the lungs than blood clots in the lower leg or other parts of the body.

What causes venous thromboembolism?

Deep vein thrombosis forms in the legs when something slows or changes the flow of blood. The most common triggers for VTE are surgery, injury, cancer, immobilization and hospitalization.

In women, pregnancy and the use of hormones, such as oral

contraceptives or estrogen for menopause symptoms, can also play a role.

Certain factors increase risk for clotting:

- Age (risk increases as age increases)
- Obesity
- Cancer
- History of blood clots
- Other chronic medical conditions, such as congestive heart failure, kidney disease, lung disease or inflammatory bowel disease
- Smoking
- Recent surgery, fracture or injury involving lower leg or pelvis
- Travel within four weeks, lasting more than four hours
- Genetic causes of excessive blood clotting (This occurs when there is an inherited or acquired deficiency of certain proteins such as antithrombin III that affect blood clotting.)

Venous thromboembolism is most common in older adults, but it can occur at any age. VTE is rare in children, though.

VTE risk factors

- Major surgery or hospitalizations — Blood clots are likely to form around the surgery site and immobility causes the blood to slow and potentially clot.
- Heart conditions, such as heart attack or congestive heart failure
- Chronic conditions including high blood pressure, diabetes and kidney disease
- Lower-extremity paralysis due to spinal cord injury
- Fracture of the pelvis, hip or long bones

- Infections, such as the virus that causes COVID-19
- Multiple trauma
- Cancer — People with cancer are more likely to be hospitalized and have surgery which leads to immobility. Cancers of the pancreas, lung, ovary, stomach, lymphoma and adenocarcinoma (cancers that start in glandular tissues) of unknown origin are associated with the highest incidence of a life-threatening blood clot.

Additional factors

Individually, the factors below are not enough to justify preventive measures for VTE. But a combination of two or more may be cause for action – and could influence the type and duration of the prevention treatment.

- Prior VTE — People with a previous episode of VTE have a high chance of recurrence.
- Age — People over 40 are at higher risk, and that risk doubles with each decade.
- Obesity — People with obesity have increased risk of VTE, and the higher the weight, the higher the risk.
- Immobility — Prolonged immobility, such as during long travel, combined with other major risk factors increases the likelihood of VTE. The blood is slowed during immobility for long periods and high altitude can activate the clotting system.
- Oral contraceptives or estrogen treatment for menopause symptoms may



cause the blood to clot more easily than normal, which causes the blood cells to bind more readily.

- Family history of VTE— especially if this is in a first-degree relative (parent, sibling, child)
- Physical inactivity
- Acquired or hereditary coagulation disorders
- Smoking
- Certain nutritional deficiencies (such as folate or vitamin B12 deficiency) can lead to acquired causes of thrombosis.

VTE and pregnancy

Women who are pregnant or have just had a baby are at greater risk of developing a blood clot. The risk is greater in the presence of the following other factors:

- Previous blood clots
- A genetic predisposition to VTE or a family history of VTE (especially in a first-degree relative like a parent or sibling)
- Obesity
- Immobilization, such as bed rest and long-distance travel
- Multiple births
- Older maternal age
- Other medical illness during pregnancy, like cancer, serious infection or toxemia/pre-eclampsia
