



Girls on the Run Northwest Indiana announces name change

Girls on the Run Northwest Indiana, a nonprofit that empowers young girls, announced that it has changed its name to Girls on the Run Indiana Crossroads (GOTR INC).

In 2024, GOTR INC expanded its service area from ten to twenty-one counties. The new service area covers the following counties: Lake, Porter, LaPorte, Newton, Jasper, Starke, Pulaski, Benton, White, Carroll, Warren, Fountain, Vermillion, Parke, Montgomery, Putnam, Vigo, Clay, Sullivan, Owen, and Greene. This expansion covers areas to the east and south of the initial service area.

Therefore, GOTR INC is all in the “name” of belonging.

“We believe our new name reflects our commitment to all the girls we serve—from

the lakefront to the cities to the rural communities,” said Jill Schlueter-Kim, executive director of GOTR INC. “We see you. We believe in you. We want you here. We hope you will join us in celebrating our new service area and our new name!” GOTR INC already has several teams in these new counties, and they look forward to growing their reach with a name that reflects both Northwest and West Central Indiana.

“When Girls on the Run Northwest Indiana applied to expand our service area, our hope was to bring Girls on the Run not to more areas on paper, but into the homes and lives of girls and families across the state. That means more girls gaining confidence, building

friendships, and learning they can accomplish anything,” Schlueter-Kim said.

GOTR INC continues to advance its mission of inspiring girls to be joyful, healthy, and confident during a pivotal time as today’s girls are facing a confidence crisis. According to survey findings reported in the 2023 Girls’ Index by Ruling Our Experiences, overall rates of 5th- to 12th-grade girls’ confidence have dropped from 68% in 2017 to 55% in 2023, with 5th- and 6th-graders reporting the most significant declines in confidence and self-perception. Participants in the GOTR program build confidence as they prepare for and complete a 5K celebratory event. In a spring 2025 end-of-season survey capturing results



from GOTR INC, 95% of girls said they were more confident, and 96% of coaches said that participants on their team were more confident.

Schlueter-Kim added, “Girls on the Run INC has served more than 24,000 girls since our opening in 2007. With research-based curricula and comprehensive national coach training, GOTR INC is meeting the needs of today’s girls.”

Dancer and spy Mata Hari is executed



Dancer, courtesan and alleged spy Mata Hari is executed for espionage by a French firing squad at Vincennes outside of Paris. She first came to Paris in 1905 and found fame as a performer of Asian-inspired dances. She soon began touring all over Europe, telling the story of how she was born in a sacred Indian temple and taught ancient dances by a priestess who gave her the name Mata Hari, meaning “eye of the day” in Malay. In reality, Mata Hari was born in a small town in northern Holland in 1876, and her real name was Margaretha Geertruida Zelle.

Hari acquired her superficial knowledge of Indian and Javanese dances when she lived for several years in Malaysia with her former husband, who was a Scot in the Dutch colonial army. Regardless of her authenticity, she packed

dance halls and opera houses from Russia to France, mostly because her show consisted of her slowly stripping nude. She became a famous courtesan, and with the outbreak of World War I, her catalog of lovers began to include high-ranking military officers of various nationalities. In February 1917, French authorities arrested her for espionage and imprisoned her at St. Lazare Prison in Paris. In a military trial conducted in July, she was accused of revealing details of the Allies' new weapon, the tank, resulting in the deaths of thousands of soldiers. She was convicted and sentenced to death, and on October 15 she refused a blindfold and was shot to death by a firing squad at Vincennes.

There is some evidence that Mata Hari acted as a German spy, and for a time as a double agent for the French, but the Germans had written her off as an ineffective agent who produced little intelligence of value. Her military trial was riddled with bias and circumstantial evidence, and it is probable that French authorities trumped her up as “the greatest woman spy of the century” as a distraction for the huge losses the French army was suffering on the western front.

Baseball 1906 World Series

The 1906 World Series was the championship series in Major League Baseball for the 1906 season. The third edition of the World Series, it featured a crosstown matchup between the American League champion Chicago White Sox and the National League champion Chicago Cubs. The Cubs had posted the highest regular-season win total (116) and winning percentage (.763) in the major leagues since the advent of the 154-game season. The White Sox, known as the “Hitless Wonders” after finishing with the worst team batting average (.230) in the American League, beat the Cubs in six games for one of the greatest upsets in Series history as the Sox out-pitched the Cubs in their first two wins and out-hit them in their last two. The home teams alternated, starting with the National League Cubs being home in Game 1.

The teams split the first four games; then the Hitless Wonders (a name coined by sportswriter Charles Dryden) exploded for 26 hits in the last two games. True to their nickname, the White Sox hit only .198 as a team in winning the series, but it beat the .196 average produced by the Cubs. In Game 3, White Sox pitcher Ed Walsh struck out 12 Cubs, breaking the previous record of 11 set by Bill Dinneen in 1903. The 1906 World Series was the first to be played between two teams from the same city or state. This series and the 1944 edition, contested between the St. Louis Cardinals and St. Louis Browns, are the only such instances outside of New York City where two teams from the same city played in the World Series. This is also the most recent World Series where both teams were

making their first appearance in the Fall Classic.

The 1906 World Series was the first appearance in the World Series for both teams, and the first of three in a row for the Cubs. The White Sox next appeared in the World Series in 1917. The next season that both Chicago teams qualified for the postseason was 2008.

The 1906 Cubs are often considered the greatest MLB team to not win the World Series. [3] In a major upset, the Cubs were beaten by their crosstown counterparts Chicago White Sox in that year's World Series. The 1906 Chicago Cubs season was the 35th season of the Chicago Cubs franchise, the 31st in the National League and the 14th at West Side Park. Skippered by player-manager Frank Chance, the Cubs won the National League pennant with a record of 116–36, a full 20 games ahead of the second-place New York Giants. The team's .763 winning percentage, with two ties in their 154-game season,[1][2] is the highest in modern MLB history.

The Sox won 93 games in the regular season—a plateau they would not reach again until the 1915 season—to claim the pennant, propelled by a historic 19-game winning streak in August. They won the league pennant largely on the strength of their pitching staff, as their team batting average of .230 was the worst in the AL. The White Sox would go on to upset their crosstown neighbors, the Chicago Cubs (who had finished 116–36 that year for the best winning percentage in modern baseball history), in the World Series, earning them the moniker of the “Hitless Wonders.”

Meet Alex



Alexandra Park is an actress, writer, and producer best known for her role on *The Royals* and the Australian series *Home and Away*. She lives in Los Angeles with her husband and dog.

My diabetes diagnosis could not have come at a worse time. It was two months before I was set to leave Australia to move to Los Angeles. My doctors advised me to cancel the move, but I was determined and moved to LA as planned. Shortly after, I accepted the role of Princess Eleanor for the TV series *The Royals* and I was off to London for filming.

On set, I was obsessed with keeping my blood sugars in range, and it was mentally exhausting and isolating at times. I developed a routine before each scene to check my blood sugar, make sure I had glucose on hand, and give myself insulin shots if needed. I had things under control, but I was always so worried that my condition would interfere with the scene or let the crew down.

During this time, I was very much in denial about my type 1 diabetes. So much so that I pushed it to the side while I struggled with the very busy schedule of being a lead actress on a TV show in a foreign country. Unfortunately, this was the start of my many scary experiences with hypoglycemia.

It wasn't until my blood sugar went so low that I went unconscious that I finally started accepting my condition. Being diagnosed with diabetes came with a new set of challenges, but it didn't have to disrupt my goals and aspirations. I realized that I could still live my life how I wanted to, as long as I made an effort to manage my condition properly.

My biggest piece of advice for people living with diabetes is to find the therapy that works best for you. MDI worked well for me for a long time, but I recently switched to an automated insulin delivery system, and it helps me balance my highs and lows, which makes a big difference in my mood, energy levels, and overall health. It works hard in the background to help keep me in range, so I can focus on the things that are most important to me.

For people living with T1D, there's often a lot of guilt or shame with navigating highs and feeling like you're not doing enough to keep them in check or that you did something wrong. It's also stressful thinking about how these prolonged highs have a cumulative impact on my health over time. The long-term complications are scary, and I certainly want to be as healthy as I can for as long as possible.

Living with diabetes isn't easy, but advancements in technology, increased awareness, and a strong community of support make it much more manageable.

PNW awarded \$1.8 million in federal funding for TRIO Student Support Services

Purdue University Northwest (PNW) has received \$1.8 million in renewed federal funding that will support resources for first-generation and low-income students, as well as students living with disabilities, through its TRIO Student Support Services (SSS) program.

The program assists eligible PNW students with comprehensive services that support their college journeys through graduation and preparation for entering the workforce or graduate school. Students benefit from one-to-one mentorship through tutoring, financial assistance and planning, counseling, career exploration and more through TRIO SSS. Eligible students also have group learning and professional development opportunities at conferences and other universities around the country.

"This grant allows Purdue University Northwest to deepen our commitment to ensuring that all students—regardless of background—can thrive academically and personally," said Jorge Lopez, Program Director. 
